- A-4 Approval of Audit presented by Max Sanborn & Sanborn Accountancy Corp. for fiscal year 2017-2018.
- ✓ Mr. Sanborn was not able to attend.
- ✓ Ms. Leal made a few comments.
- ✓ Mr. Chavez would like to go through the audit. Ms. Leal sent the Board Members via email a copy of the draft audit.
- ✓ Corrections made to the audit Measure B ending on 2029 and not 2020. Also, one of the last pages Mrs. Culbertson was listed as Clerk and it should be Mrs. Zavala.
- ✓ We still have \$750,000 assigned for special reserve.
- ✓ We have \$1,646,548 in Measure B as of June 30, 2018. We accumulated about \$227,705 from July thru November 2018 and \$40,000 for the month of December 2018 that gives us about \$1,914,253 in Measure B to date.
- ✓ The Huron Project will cost:
  - > BVI \$1,420,000
  - > DST \$106.000
  - > CM \$40,200

Total Cost \$1,566,200 plus 10% \$156,700 which will bring us to \$1,722,900. We also have a budget expense of \$108,000 which will bring our total cost to \$1,806,253 and we are about \$100,000 ahead on the budget. We still average \$40,000 a month from Measure B.

✓ Mr. Zubiri would like to get a printed copy when we get documents of this size just for reading purposes.
