#### V. DIRECTOR'S UPDATE

• Huron Project: Mr. Chavez explained about the three options we have concerning more water needed for fire safety. New law states we need to put in sprinklers, but we would also need to put them in the old library. Fire Marshal gave us three options; put a dividing wall with fire retardant, put a 2,500 gallon tank with a pump, and City of Huron only has an 8" line throughout the city. On Palmer St. which is right on the side of the library they are putting a new line and a new fire hydrant right next to the library, but that will still not be enough pressure for both buildings. We need to have at least 2,500 PSI and the line is only giving us 1,100 right now. Sprinkler System is what we are going with. Cost for both buildings will be \$55k we have more than enough money in Measure B to cover this.
